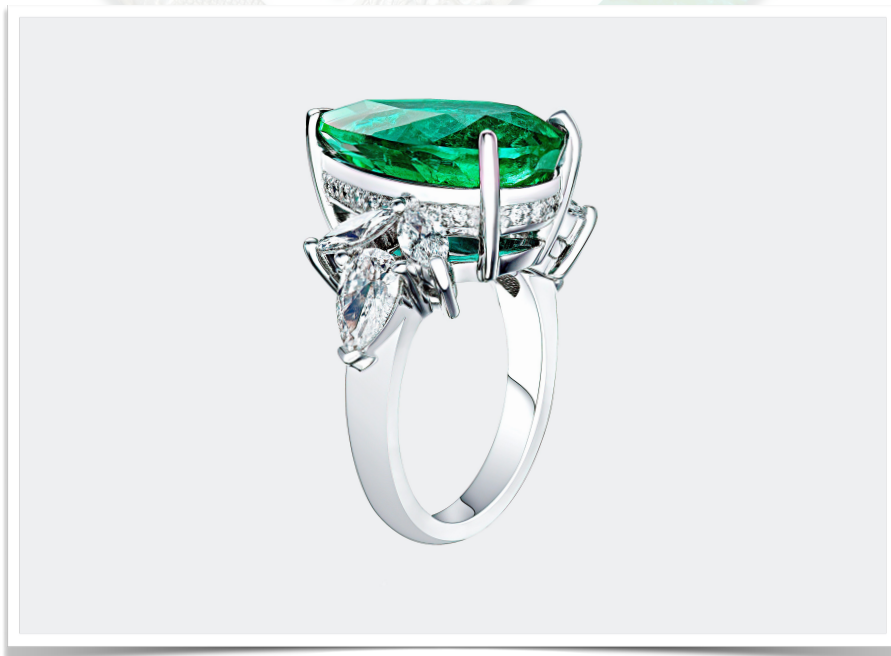

Containing; One hundred-seventy-six (176) baguette, pear, marquise, and princess cut natural diamonds with a total weight of 41.38-carats, color grade D-F, clarity grade VVS1-2, plus five (05) fine quality pear shape natural Colombian emeralds with minor clarity enhancement and a total weight of 39.52-carats. Graded as mounting permits.
